

APPLICATION FOR RECONSIDERATION OF GRADES

Reconsideration of individual Marks and Grades or Reconsideration of a Final Grade

Students may apply to have the mark or grade given for an individual assessment or the final grade given for a module reconsidered. This form may be used in either case, but different timeframes apply – please read the notes carefully together with the information provided in the Academic Regulations. Please ensure you complete both sides of this form and submit this with your supporting documents and the required fee as detailed in Section Two. Reconsideration of marks or grades is not based on impaired preparation, attendance, or performance - an application for Special Consideration should be completed in this case.

• Reconsideration of individual marks or grades

This is a formal request to have an item of assessment reassessed based on a claim that assessment practice (validity, reliability, authenticity etc) has been compromised. Applications should be made on this form and submitted within 10 working days of notification of the result.

• Reconsideration of final grade

This is a formal request to have all items of assessment reviewed and remarked (not by the original assessor) against the original marking criteria/schedule for a module. Applications for reconsideration of a final grade will only be considered when ALL items of assessment have been completed. Applications should be made on this form and submitted within 20 working days of notification of the final grade.

Completed applications should be submitted either in person to the Student Enrolment & Information Centre (SEIC) or emailed to academicservices@wintec.ac.nz. Applicants will be notified in writing of the outcome of the reconsideration. Reconsideration may lead to no change or an amendment either raising or lowering a mark or final grade.
