These regulations should be read in conjunction with the Institute's Academic Regulations.

## 1. Transition Arrangements

## 1.1 Principles:

These principles underpin the application of the transition regulations:

- a) Transition arrangements will seek to minimise any disadvantage to students;
- b) The graduate profile will be used as a guide for developing transition arrangements;
- c) Individual student transition arrangements will maintain the academic integrity of the qualification and will ensure that students who graduate will meet the graduate profile.

#### 1.2 **Transition:**

- a) Paetahi Tumu K\u00f6rero Bachelor of Counselling is replacing the Bachelor of Applied Social Science (Counselling). There will be no new enrolments in the Bachelor of Applied Social Science (Counselling) after 31 December 2015;
- b) Students enrolled in Year 1 of the Bachelor of Applied Social Science (Counselling) in 2015 will transition to Paetahi Tumu Kōrero Bachelor of Counselling. All other students will complete the Bachelor of Applied Social Science (Counselling).
- c) The Bachelor of Applied Social Science (Counselling) will not be offered after 31 December 2017. Students who have not completed the Bachelor of Applied Social Science (Counselling) by 31 December 2017 may transition to Paetahi Tumu Korero Bachelor of Counselling. Individual transition arrangements will be negotiated, documented and approved by the Team Manager.

#### 2. Admission and Entry

#### 2.1. General Academic Admission

Candidates are required to have:

- a) University Entrance which is NCEA Level 3 comprised of 60 credits at NCEA Level 3 or above and 20 credits at NCEA Level 2 or above, including:
  - i. 14 credits each at NCEA Level 3 in three <u>approved subjects</u><sup>1</sup>; **and**
  - ii. <u>Literacy</u><sup>2</sup> (10 credits at NCEA Level 2 or above made up of 5 credits each in reading and writing); **and**
  - iii. Numeracy<sup>3</sup> (10 credits at NCEA Level 1 or above); or
- b) A relevant qualification at Level 4 on the NZQF; or

c) Equivalent.

### 2.2. Special Admission

Domestic applicants aged 20 years or above who have not met the General Admission or entry requirements for a programme but whose skills, education or work experience indicate that they have a reasonable chance of success may be eligible for Special Admission. Special admission will be granted at the discretion of the relevant Head of School/Centre Director or designated nominee. Such applicants may be required to successfully complete a foundation, bridging or tertiary introductory programme as a condition of entry into higher level programmes.

#### 2.3. Provisional Entry

Domestic applicants aged under 20 years who have not met the general academic admission and entry criteria for a programme but who can demonstrate a reasonable chance of success through other educational attainment and/or work or life experience may be eligible for provisional entry at the discretion of the relevant Head of School/Centre Director or designated nominee. Provisional entry places restrictions on re-enrolment to be lifted if the applicant's performance is deemed satisfactory by the relevant Head of School/Centre Director or designated nominee.

#### 2.4. Selection Criteria

- a) In order to comply with the provisions of the Vulnerable Children's Act, 2014 and Child Protection Policies for all 'specified organisations' providing a 'regulated service', all candidates/students will be subjected to safety checks. These will include but are not limited to;
  - i) A Formal Interview
  - ii) Referee Checks
  - iii) A Police Vet Check
  - iv) A Risk Assessment

Any unsatisfactory result arising from the full safety checking process may result in the candidate/student being precluded/declined entry or withdrawn from the programme of study. Furthermore, students must declare any pending or new convictions arising during any stage throughout the entire enrolment period. A conviction or failure to declare a conviction may also result in the student being immediately withdrawn from the programme. Persons who are convicted of 'specified offences' will not be accepted onto any programme that requires that Person to work in an organisation providing a regulated service.

- b) Candidates will be required to provide a record of prior qualifications, employment history, work experience and two written references (form provided)..
- c) Candidates will be required to attend a selection interview/hui. Selection will be made on the basis of the candidate being able to demonstrate a reasonable likelihood of success in the programme.
- d) Candidates are required to indicate whether they have been convicted of, or are being prosecuted for, a criminal offence. Some types of criminal conviction may limit the ability to secure practicum placements and therefore complete the programme.

# 2.5 English Language Requirements

Candidates who have English as a second language are required to have an International English Language Test System (IELTS) score of 6.5 across all bands; or equivalent.

#### 3. Transfer of Credit

- 3.1. Transfer of credit or recognition of prior learning (RPL) is available for this programme.
- 3.2. Transfer of Credit including recognition of prior learning (RPL), will not normally be awarded for more than 50% of Paetahi Tumu Kōrero Bachelor of Counselling.

3.3. Normally no transfer of credit or recognition of prior learning (RPL) will be awarded for successful study that took place more than 5 years prior to the date of first enrolment in the programme.

#### 4. Programme Requirements

- 4.1. Every candidate for Paetahi Tumu Kōrero Bachelor of Counselling shall to the satisfaction of the Academic Board follow a programme of study for a period of normally not less than 3 years.
- 4.2. Each candidate's programme of study shall comprise compulsory modules totalling 330 credits and optional modules totalling 30 credits in section 7 of these regulations.
  Candidates may enrol part-time. Because of the pre- and co-requisites, students will be required to follow a designated part time programme of study. Part-time programmes of study will be negotiated, documented and approved by the Team Manager or delegate.

## 5. Completion of the Programme

5.1. A candidate will normally complete Paetahi Tumu Kōrero Bachelor of Counselling within six years, unless an extension is granted by special permission of the Centre Director or delegated nominee.

#### 6. Award of the Qualification

6.1. Candidates who successfully complete the requirements in clause 4 will receive the award of Paetahi Tumu Korero Bachelor of Counselling.
