NURS801

Integrated Science and Assessment

Duration: One semester

Credits: 30 Level: 8

Location: Hamilton City Campus Semester 1: 31 January, 1 February, 8–9 March, 19–20 April, 17–18 May

This module, for registered nurses, prepares you to develop an advanced understanding of pathophysiology in complex health states.

Topics covered include integration of bioscience at a cellular level, scientific evidence, empirical knowledge, comprehensive health assessments, and clinical reasoning, which facilitates identifying actual and potential health needs in specific communities and populations.

NURS802

Reasoning in Practice

Duration: One semester

Credits: 30 Level: 8

Location: Online and Hamilton City

Campus

Semester 1: 31 January, 1 February, 8–9 March, 27–28 April 1–12 June Semester 2: 6–7 July, 10–11 August, 28–29 September, 2–3 November

This module fosters the development of reflexive registered nurses who critically evaluate clinical knowledge, research evidence, professional values, and regulatory frameworks for reasoning in practice. Thus, cultivating inquiring and thoughtful nurses as practitioners who collaborate with clients, communities, and other health professionals within the interprofessional contexts of practice.

NURS806

Registered Nurse Prescribing Practicum

Only available to students eligible for the Registered Nurse Prescribing pathway.

Pre-requisite

Attain a B pass or better in NURS801 Integrated Science and Assessment, NURS804 Pharmacology for Nursing Practice and, NURS812 Advanced Practice in Long-term Conditions. Have completed three years' equivalent full-time practice in an area of common and long-term conditions nursing.

NURS807

Advanced Diabetes Nursing Practice

Duration: One semester

Credits: 30 Level: 8

Location: Hamilton City Campus Semester 2: 17- 18 July, 21- 22 August,

9-10 October

This module will enable Registered Nurses to advance their knowledge and skills in diabetes nursing practice. Fostering an approach to learning that supports critical inquiry and clinical reasoning in the specialty practice of diabetes nursing in partnership with people and their whānau, families and communities. Students will explore issues in the clinical management of diabetes using theoretical and evidence-based perspectives and develop specialty nursing care strategies to meet the challenges within the New Zealand healthcare environment.

NURS809

Advanced Nursing Practice in Breast Care

Duration: One semester

Credits: 30 Level: 8

Location: Hamilton City Campus **Semester 1:** 13 February online start,

workshops 5-6 April

This module is designed to enable registered nurses to advance their knowledge and skills for nursing practice to meet the health care needs of clients using breast care services. Participants will explore nursing roles and relationships within interprofessional breast care services and develop strategies to advance nursing knowledge and therapeutic skills for a holistic approach to women's health.

NURS812

Advanced Practice in Longterm Conditions

Duration: One semester

Credits: 30 Level: 8

Location: Fully online Semester 2: 10 July

This module enables registered nurses to develop advanced knowledge, skills, and capability to work with people, families, and whānau who are affected by one or more long-term conditions. You will gain an in-depth understanding of the complexity of living with a long-term condition. In addition, you will develop a deeper understanding of the relationships between people, systems, and the socio-political and cultural contexts that may influence the improvement and maintenance of health, wellbeing, and quality of life.



Advanced Nursing Practice

Duration: Full year **Credits:** 30 **Level:** 9

Designed to consolidate and articulate a broad base of empirical, experiential, professional, and contextual knowledge for the comprehensive and advanced clinical management of health consumers with long-term and common or acute conditions. Present evidence towards meeting the nurse's Nursing Council of New Zealand competencies practitioner scope of practice.

NURS902

Nurse Practitioner Practicum

Duration: Full year Credits: 30 Level: 9

Location: Hamilton City Campus **Dates:** 9–10 February, 22 March, 20–21 April, 20–21 July, 14 September, 19

October

Pre-requisite

Undertake NURS902 Nurse Practitioner Practicum. Candidates must be employed in a relevant area of practice for a minimum of 24-hours-per-week.

Undertake 300 supervised clinical hours for the nurse practitioner practicum and provide evidence of your developing practice through supervision and case review towards meeting the Nursing Council of New Zealand Competencies for the nurse practitioner scope of practice.

NURS903

Dissertation

Duration: 18 months (3 semesters)

HSIP817

Advance Practice Skills in Mental Health and Addiction

This module aims to develop a thoughtful and enquiring practitioner ready to work alongside tangata whaiora experiencing mental health and addiction issues through evidence-based practice skills. You will demonstrate advanced culturally responsive skills in relational practice in meeting tangata whaiora needs, and enhancing wellbeing in the context of mental health and addiction in New Zealand.

HSIP818

Applied Theoretical Approaches for Mental Health and Addiction

Duration: One semester

Credits: 30 Level: 8

13-14 May

This module integrates best practice approaches and engages participants in learning around tangata whaiora centred case formulation, treatment and intervention practice skills relevant to mental health and addiction in New Zealand. You will develop culturally responsive knowledge, enabling you to work across and simultaneously with tangata whaiora experiencing co-existing mental health and addiction diagnoses and presentations.

Comprehensive Assessment and Treatment Planning for Mental Health





HSIP805

HSIP806

Designing Practice

Duration: One semester

Credits: 30 Level: 8

Location: Hamilton City Campus Semester 1: 9–10 February, 24 February (and one further date to be negotiated)

This module prepares students to respond innovatively to complex practice problems. Students will work through a real world practice problem, learning skills for working collaboratively in inter-professional teams to design creative responses to problems. The emphasis will be on service design.

HSIP807

Professional Practice in Context

Duration: One semester

Credits: 30 Level: 8

Location: Hamilton City Campus Semester 1: 31 January, 1 February, 8–9 March, 27–28 April, 1–2 June

HSIP901

Industry based project

Duration: One year Credits: 60

This module enables experienced health and social practice practitioners to engage in industry-based activities to explore relevant and meaningful solutions for practice related challenges in their workplace. The industry-based project aims to support practitioners in building resilience and increased capacity within organisations and communities of practice.

HSIP902

Evidence Based Practice Project

Duration: One semester

Credits: 30 Level: 9

Location: Hamilton City Campus Semester 1: 2–3 February, 16 March,

3 May

Semester 2: 4–5 July, 17 August, 11

October

This module focuses on developing a supervised evidence-based project in which you will choose a specific issue related to your area of practice. You will critically explore, analyse and articulate the findings that result from this enquiry.

HSIP903

Dissertation

Location: Hamilton City Campus Semester 1: 2–3 February, 3 May (and two days in Semester 2 as negotiated) Semester 2: 4–5 July, 11 October (and two days in Semester 1 the following year as negotiated)

This module aims to guide students through the identification of a research topic, the construction of a research proposal, gaining ethical approval and conducting a major written project relevant to their field of practice. Students draw on learning and skills acquired in the taught components of the Master of Professional Practice programme to develop a scholarly piece of work that demonstrates skills in data collection, critical analysis and proficient written communication of ideas.
